Welcome to FOCUS Dance Center for the Performing Arts where our "FOCUS" is on inspiring students and athletes of all ages and levels in the pure fun and artistry of dance performance and fitness. Our talented master faculty will provide you with the benefits of physical, mental and emotional health and wellness, through the very best quality training and techniques. We are thrilled you have chosen our Performing Arts Center, and look forward to the opportunity to work with you. Here's to a year filled with new, fresh, exciting, and inspiring beginnings!

- Our 2020.2021 Season runs Sept 14, 2020 August 28, 2021 with each level following a full season of carefully planned curriculum and training to successfully master the skills of that level. Our classes train for the full season in dance technique, performance, and fitness in preparation for our Honors Performance Concert Series which will be either Virtual, Outdoor Amphitheatre or Indoor venue depending on the state of the pandemic and the mandates.
- Quarterly showcases in December, March, June and August give you the opportunity to enjoy the growth and positive improvements of the students throughout the season as well as the opportunity to be creative with student created costumes and fun home backgrounds for the virtual students.
- Honors Performance Concert Series preparations include a \$95.00 plus tax required PERFORMANCE COSTUME/MATERIALS FEE for each class your child performs. Please be aware that you may have some additional costs for the performance, i.e. accessories for costumes, basic makeup, (theatre tickets if mandates and safety allow) etc., and optional costs if you'd like to order pictures, DVD's and flowers etc.
- Your Honors Performance Presentation is very important to the process of your dance training, learning how to display your skills, and the art of performance. The student gains confidence, teamwork, and self-esteem from the experience. Students who complete the season of training and perform in the Honors Performance, will also receive the honor of a Certificate of Participation presented to them at the time of the performance.
- We continue to maintain a hopeful attitude, while also realizing a return to normal times is still indefinite. We would love to be able to resume full in-person classes as soon as possible, so in the meantime, we will continue to offer limited space indoor, and outdoor group classes, small group bubble custom classes, (customized group privates of no more than 6 students where

students choose to train with other students per an agreement.) as well as solo, semi, tri privates, all contingent on mandates and safety. We look forward to when the community is in a much better place with respect to Covid-19

- We have optimized our new "Season 18" Hybrid (aka Virtual and in-studio) Live Interactive dance and fitness training schedule to motivate our dancers and provide the absolute best training and inspiring experience possible, by engaging dancers in a positive program that will progress almost as much as in a full in-person experience.
- Since the safety of holding in-person classes, during this time, greatly depends on the number of dancers in the class, we anticipate making adjustments to small groups of dancers before easing into a normal sized class as mandates and safety allow. This is separate from and in addition to the Virtual Live Interactive Classes.
- Now that we are in a position to offer in-person options, our in studio safety guidelines will be implemented. - In July the faculty evaluates each student, filling out a report card for placement for the up-coming New Season in September 2021. These level recommendations will be given to you as a guide for the new season registration.

- NON COMPETING STUDENT TUITION POLICIES.

- A non-refundable \$25.00 registration/re-activation processing-fee per student is applied at time of registration, and when reactivating your account.
- FOCUS operates on one twelve-month annual season installment, months of September-August. As a courtesy, the total annual season fee has been divided into consistent monthly tuition installments, month by month regardless of how many weeks are in a month. This is both a courtesy to our clients and an efficient way for us to operate.
- Payment Options: You can choose to pay upfront for the entire year or on a month-by-month basis
- Monthly Tuition installments are due on the 1st of every month and must be paid prior to attending class.
- Tuition received after the 10th of the month will result in a \$25.00 late fee.
- Tuition is due regardless of attendance in class. Policies for Make-ups for classes missed, listed below.
 - o Note: Any client may cancel their membership before the first of the month. Though classes are taught on a full season commitment, there are no contracts for non-competing dancers!
 - o Tuition can be paid for the full season, in quarterly installments or monthly.
 - Clients are responsible for the tuition until they withdraw from the class. You may email to request an add/drop form. Your class is not dropped until you receive a confirmation email. Withdrawals will not be accepted over the phone.

Holiday-Vouchers are available at the front desk for students affected by the following holidays:

- Thanksgiving (Thursday, Friday, Saturday)
- Easter (Friday, Saturday, Sunday)
- Memorial Day (Monday)
- Labor Day (Monday 2021)
- Holiday-Vouchers cannot be applied to tuition.
- In the event you miss a class, you may request a Make-Up Pass. This pass allows you to attend any class of the same level or one level below in your age.
- Make-up passes are only issued to students that are still enrolled in the studio.
- Make-Up Passes must be requested within one month of the missed class.
- There will be no refunds for missed classes.
- Students with poor attendance may be required to take private lessons to learn missed material.
- Be sure you provide us with your EMAIL ADDRESS. Our main form of communication is via FOCUS Talk Newsletter, and e-mail. Please ensure we have your correct e-mail on file, and notify us in the office if you change it on the parent portal.
- Returned checks, will be charged the initial amount plus the bank and FOCUS processing fees. After 3 returned checks we will accept payment in cash only.
- Special circumstance refunds are accompanied by a \$25.00 processing fee.

DANCE CENTER POLICIES

Dancers:

In-Studio Classes:

- For In-studio class instruction please read attached safety guidelines and disaster preparedness plan on our website
 Virtual Classes:
- Please arrive at the designated class time, ready to dance. For safety reasons, dancers who arrive more than 10 minutes late will need to sit and observe.
- Virtual class Instruction begins 5 minutes into each class and instruction ends 5 minutes before the end of the hour or half-hour depending on when class is scheduled.
- Please wear proper attire and appropriate shoes for dance. For safety reasons, dancers without proper attire will not be able to participate.
- Dancers in all ballet classes must wear their hair in a bun. For all other classes, hair must be secured off the face and neck.
- Please put yourself on mute until the instructor requests otherwise.
- Make sure to never go barefoot if you are needing to dance on carpet. Socks or dance shoes only.
- Make sure your dance space is safe to move around in.
- During class, dancers may ask instructors questions, please raise your hand. All other talking is inappropriate.
- Please be respectful and considerate of instructors and fellow students.
- Disruptive behavior will result in temporary or permanent loss of class participation privileges.
- Ask instructor for permission to leave the screen.
- No food, drinks, or gum is allowed in the dance class. Closed water bottles are acceptable and encouraged. All food must be eaten before or after class.
- No cell phone use during class.
- Students with inconsistent attendance may be required to take private lessons to learn missed material.

Parents:

- Please do not interrupt classes to speak with instructors. Contact the FOCUS
 Dance Center office with any questions or concerns you may have regarding our
 instructors, classes, or placement. Please contact the office to make an
 appointment to speak with the instructor.
- FOCUS reserves the right to cancel classes due to low enrollment.
- Please call in advance to check on the status of a particular class that is listed as Call First.
- For Creative Dance levels and higher...In Dance, tights are considered underwear. It is difficult to dance with too many layers when wearing tights, leotard and also underwear.

• Parents of Tiny dancer classes, please stay during their class time to assist if they need to use the bathroom or have other needs. Please also always have them go to the bathroom before class.

- Warm-up attire is at the discretion of the instructor.

I understand the FDC Activation Fee Policy

There is an annual \$25.00 non-refundable registration fee for each dancer.

Families must give a 30-day notice if you choose to take a break from FOCUS. If a dancer takes a break mid-season, you are required to re-activate and pay the \$25.00 re-activation fee.

I understand the FDC tuition policy

- Tuition is due on the 1st of every month.
- Tuition received after the 10th of the month will incur a \$25.00 late fee.
- Tuition is due regardless of attendance of class.
- I understand the FDC class withdrawal policy.
- I am responsible for the monthly tuition until I withdraw from the class.
- I withdraw from a class by completing an add/drop form.
- Withdrawals will not be accepted over the phone. You may email your request to complete the add/drop form. Your class is not dropped until you receive a confirmation email.
